

## Refining Your Institution's Special Review Process

Since the implementation of the ACGME Next Accreditation System, the Graduate Medical Education Committee (GMEC) process for effective oversight and monitoring of programs has evolved into a Special Review process. By developing a consistent targeted approach to execution and oversight of Special Reviews, institutions and programs will be better prepared to conduct robust reviews by: defining roles, providing guidance to special review teams, and having a standardized approach to monitoring corrective actions and outcomes that lead to sustained improvement.

- Identify the Institutional and Special Review roles and responsibilities in your institution;
- Describe the program and GMEC roles in addressing action items; and,
