

ACGME Updates: Common Program Requirements Sections I-V – New and Improved for July 2019

As July 2019 approaches, each of us in the GME Community prepares for the implementation of the new Common Program Requirements, Sections 1 through 5. While we await what each change will mean as it is incorporated into individual Review Committee Program Requirements – by specialty – it is helpful to anticipate and start implementing those that are transforming our institutional approach to GME. As the ACGME continues to fulfill its promise to give us outcomes-based accreditation requirements that offer broader interpretation and locally meaningful experiences for our residents, we look to July 2019 and the new Common Program Requirements to guide and structure our Community's conversations. Ms. Greenwood-Clark will describe the efforts that should already be underway as we prepare for the next academic year, and the careful prospective planning that will enable us to be successful as we look ahead.
