Program assessment is an annual process that is required of all ACGME accredited residencies and fellowships. This process is often incompletely understood and inadequately utilized as a tool for program administration best practices. In the ACGME New Accreditation System (NAS) the role of program assessment will take on a more important role as the ACGME looks to strengthen its oversight on a year to year real time basis. She is responsible for oversight of accreditation within the GME office. Her committee has implemented and refined the Annual Program Evaluation and created a corresponding feedback mechanism to program directors and the GMEC.

Moderator: Quinn Turner, MS, C-TAGME, is Manager of Medical Education Services and Coordinator of the Transitional Year and Podiatric Medicine Residency Programs at Iowa Methodist Medical Center in Des Moines. Quinn has been a member of AHME since 1992 and currently serves on the Board as Member-at-Large and as the inaugural Chair of the newly-formed Council of Program Administrators and Coordinators.
