

**Clinical Competency Committees:
The ABC's of CCC's**
Tuesday, October 7, 2014 ~ 1:00-2:00 p.m. Eastern

With the start of Phase II of the ACGME's Next Accreditation System in July 2014, all residency programs must now have established a Clinical Competency Committee (CCC) charged with reviewing resident progress and rating each resident's achievement of the milestones. ACGME requirements concerning the size, composition, scope of work, and reporting requirements of the CCC will be reviewed. The ACGME sponsored pilot testing of the Transitional Year Residency Program Milestones in 2013. Twenty TY residency programs from across the country participated in this six-month pilot test. Results from this pilot test will be shared. Best practice recommendations concerning CCC composition, workflow, performance, and milestone reporting will then be shared.

Objectives:

At the end of this teleconference session, the learner should be able to:

- Understand ACGME requirements for creation of Clinical Competency Committees and the size, composition, scope of work and reporting requirements of these committees;
- Describe key results from the 2013 Transitional Year Milestones Pilot Testing Program about how these 20 programs established Clinical Competency Committees and how these committees accomplished review and rating of each resident's milestone performance; and
- List best practice recommendations concerning CCC size, composition, workflow, performance, and reporting of resident milestone performance.

Speakers:

Louis J. Ling, MD is Senior Vice-President for Hospital-based Accreditation at the ACGME, responsible for the operation of the review process for the nine hospital-based specialties. He is a graduate of the University of Minnesota Medical School and did his residency in emergency medicine at the University of Chicago. He practiced for 30 years at Hennepin County Medical Center where he also directed the emergency medicine, medical toxicology and transitional year training programs. Most recently, before joining the ACGME, Dr. Ling was Associate Dean for Graduate Medical Education at the University of Minnesota Medical School, and concurrently Chief Medical Education Officer at Hennepin County Medical Center, in Minneapolis.

Steven R. Craig, MD is the current President of the Association for Hospital Medical Education. He is a graduate of the University of Iowa College of Medicine and completed his internal medicine residency training at the University of Colorado. Dr. Craig serves as Director of the Transitional Year Residency Program at UnityPoint Health-Des Moines in Des Moines, Iowa. He also serves as an Assistant Dean for the University of Iowa Carver College of Medicine with oversight of the Des Moines Branch Campus.

Moderator: Daphne Norwood, MD, MPH, FACP is Transitional Year Program Director at the University of Tennessee Graduate School of Medicine. Dr. Norwood is Chair of AHME's Council of Transitional Year Program Directors.
