## One, Two, Three, Sync! Milestones 2.0 and You

The ACGME milestones represent the introduction of outcomes based medical education to the process of resident and fellow education. The Council of Transitional Year Program Directors introduces Dr. Stan Hamstra from the ACGME to discuss how the nascent milestones process has informed the current milestones 2.0 changes, what this means for programs and their administration and how to prepare. Included will be a discussion on the evolution and incorporation of harmonized milestones. Dr. Hamstra will share lessons learned implementing the first milestones process which helped to configure the updated milestones being released currently. Dr. Hamstra works with medical subspecialty societies, program director organizations, the American Board of Medical Specialties, and specialty certification boards.

She currently serves as the Transitional Year Program Director and Co-Chair of the UPMC ME Professional Development Committee.
